6.0 PRESENTATION OF THE FINANCIAL REPORT FOR THE 2022/2023 FISCAL YEAR

- Mr. Matt Martin, the FHA's Treasurer, presented a high-level overview of the financial report.
- Mr. Matt Martin explained that we had a review of engagement report by John Vandevelde. The 22/23 season was the first full season of operation since the onset of covid, numbers do reflect that – which is a great positive.
- Overall revenue was up 153k. A big driver of the increase was the increase in registration in House league and Rep levels. We also did see a large number of revenues come from our FHA tournament (approx. 81,000) as well as we did see improved community support in regard to sponsors.
- Expense side This year the biggest fee for the association is ice rental cost there was an increase in number of teams for the year compared to past years as well as previous years we had temporary covid shutdowns. In addition, there was also an increase in the hourly rental fee from the city.
- Unfortunately, we did receive an unexpected invoice for ice rental for a total of 33k, which was an old ice rental invoice from city of Hamilton. It appears they changed over their accounting system, this invoice was lost, and we were on the hook to pay this season.
- The FHA invested 20k in a camera system which was heavily used by the rep teams
- Balance sheet cash balances are up 11k
- Mr. Matt Martin also discussed why we didn't make more money at tournament 6
  teams backed out at the last minute and unfortunately, we had not collected their
  money. Thoughts for next year: we may hire a tournament director, charge for vendors,
  ensure teams pay upfront.

Motion approved by Shawn A to approve the financial statement, seconded by Katie G. – motion carried

# 7.0 APPOINTMENT OF JOHN VANDERVELDE, CPA AS FHA EXTERNAL ACCOUNTANT FOR THE 2023/2024 FISCAL YEAR

- Mr. Sones explained that the FHA board is recommending that a review engagement again be performed by the external accountant for the 2023/2024 fiscal year.
   Accountants can perform three different levels of reviews. The FHA board felt that it would be prudent to continue with a review engagement for the 2023/2024 fiscal year.
- Motion to approve review engagement of FHA financial statements for the 2023/2024 fiscal year be performed by external accountant made by Jeff V. and seconded by Ryan K. Motion carried.
